### Re: Inquiry regarding safety of artificial water fluoridation chemical

Dear Dr. de Villa, Medical Officer of Health,

I draw your attention to a recent article in the Brampton Guardian where you made the following statement.

"Peel health staff will not 'cherry-pick' studies to support water fluoridation: Medical Officer of Health" and then I heard about this tweet.

@picardonhealth I recently reviewed safety of fluoridation for a city council. 0.7 ppm is safe, full stop. Same for fluoridation agent HFSA"

I'm a retired Registered Nurse and have been researching the practice of artificial water fluoridation for a number of years and am shocked to learn that the practice continues without toxicology studies showing that the chemical in question, Hydrofluorosilicic Acid is safe for human consumption for short and long term use particularly for the sub groups who are at

greater risk of harm such as unborn children, infants, renal and cancer patients, people with autoimmune disorders, hypothyroidism, diabetics, etc.

My neighbor is a Registered Nurse with a university degree and she works at a local Health Unit. She told me that it's the Health Unit's policy to tell new mothers to mix baby formula with fluoridated tap water as long as it's boiled for five minutes prior to use. Unfortunately, I've only been able to locate many scientific studies showing harmful effects regarding the consumption of Hydrofluorosilicic Acid on human health.

Dr. de Villa, you said that you recently researched the issue of 'safety' yourself. For that, I'm very grateful as it will relieve my worry somewhat.

Please refer me to the **toxicology/scientific peer-reviewed studies** showing that the toxic waste by-product, Hydrofluorosilicic Acid which is a known **neurotoxin** used to mass medicate the public is safe, for human consumption.

I've been searching this issue for a long time and haven't been able to locate the studies and when I asked my City Councillor for them - they are nowhere to be found. I draw your attention to a letter from Health Canada stating they do not have any such studies. I understand the Concerned Citizens of Peel to End Fluoridation have provided the letter to the Region and to refresh your memory, I have attached a copy for you.

Please find attached an extensive bibliography from a retired Professor, Dr. Roger Masters. Dr. Masters many studies on the chemical in question, shows beyond a doubt that there are many adverse harmful effects on human health when exposed to this toxic chemical.

Given you tweeted that you had done your research and found HFSA was safe in the drinking water, I was most surprised after ten weeks of non response that you indicate by your acceptance of Dr. Mackie's submission, that it contains the necessary studies for you that show HFSA is safe to put in the drinking water. This is very alarming to say the least, especially when it's a review and not actual toxicology studies showing HFSA in drinking water is safe for human consumption. This means to me that you cannot honestly say that the toxic waste, HFSA is safe for human consumption in drinking, cooking and bathing water. Your tweet was misleading, as are your statements to Peel Regional Council and the citizens of Peel Region who you are well-paid to protect, that artificial water fluoridation with HFSA is safe and effective. It appears that you do not have the links to the required toxicology studies to show it is safe.

I am greatly disappointed that you and Dr. Mackie as doctors, would recommend the addition of a toxic waste by product which cannot be legally put into the air, lakes, rivers or sea where it's manufactured, is collected, put into a holding pond, then into a tanker truck and magically transforms into an unregulated drug to prevent cavities on its way to a fluoridating community where it turns a profit for the manufacturer rather than a huge expense to be legally environmentally disposed of without checking for toxicology/safety studies showing HFSA is safe in drinking water for human consumption. I wonder if the very generous salary that you and the other Medical Officers of Health receive is an obstacle that prevents you from doing your due diligence to discover and share the truth about fluoridation. Given the NSF Standard 60 certificate requires 20 toxicology studies, I wonder why you did not attempt to obtain the links to the legally required toxicology studies from the National Sanitation Foundation. If you had taken the time to inquire, you would have learned the truth-- they don't have them. Being they are apparently required, as NSF themselves state on their website, one wonders why they don't have them and how NSF can legally issue a certificate of safety. Here is what a manufacturer must do to meet the NSF Standard 60 according to the NSF website:

- 7. We grant NSF certification for compliant products and you can use the NSF mark on products, packaging and marketing materials.

Let the experts at NSF help you by expediting your time to market, bundling services and reducing the number of contracted service providers by reducing facility audits and overall costs."

......The National Sanitation Foundation (NSF) certifies fluoridation materials to be safe. Based on this certification some states and some water districts require that fluoridation materials be added to drinking water. NSF Rule 60 states that some 20 toxicological tests of fluoridation materials must be done. NSF has admitted that the tests are not done. Because states and water districts make the decision to require fluoridation based on NSF's

certification, and because said certification is false and fraudulent, and because NSF is usurping the role of the FDA in certifying the fluoride drug to be safe, the FDA should to order NSF to cease in its certification of fluoridation materials to be safe......

I have personally inquired and NSF does not have the toxicology studies even though, they publish they are required, nor do the manufacturers who must provide them for certification. Do you not find it incredulous that NSF does not have the required studies when they are legally required for the Standard 60 certification? I have hope that you and everyone else copied on this email does not believe me and does their own research by writing their own letters to find out for themselves that there are no toxicology studies showing HFSA is safe for human consumption in drinking water. I will provide a list of manufacturers and addresses upon request.

The big question is "why are our trusted doctors and dentists lying to us intentionally or unintentionally? Once our elected officials learn the truth for themselves, surely they will do the right thing and vote to end AWF unless of course they possibly want political power more than taking the right action. Also, there is the distant hope that some Medical Officers of Health may find the courage to tell the truth thus protecting the citizens who pay them for protection, from undue harm and suffering.

The time has come to end this horrible scam on humanity. Elected officials need to do their due diligence and vote for the end of fluoridation while the dentists, Medical Officers of Health and government leaders supporting AWF need to admit their error.

Dr. de Villa, it is very sad that you, with your gift of a brilliant mind, have put so much energy and money into an extensive education, yet you fail to do your own independent due diligence on AWF or follow your Hippocratic Oath, which is to first do no harm.
