

"a **permanent hypomineralization** of tooth enamel due to **fluoride-induced disruption of tooth development**... in people with high exposure... occurs only when exposure to fluorides happens during tooth formation"

- 3% with moderate dental fluorosis
- 1% with severe dental fluorosis

PG 146: "Fluorosis is caused by excessive exposure to fluorides during early childhood.

Fluorosis results in tooth discolouration, which may range from patchy white staining of the tooth enamel in its mildest form, to pitted brown staining in its most severe form.

...Oral infections can affect a person's psychological and social well-being.."

BUT DENTAL FLUOROSIS CANNOT?

Peel's Commissioned 2007 Fluoridation Study by Dr. Dick Ito

- 7 year-old school children
- Fluoridated Brampton vs Unfluoridated Caledon
- SES-matched samples
- Results:
 - No difference in cavity rates
 - DOUBLE the dental fluorosis for fluoridated kids any degree of dental fluorosis: 34% vs. 16% fluorosis of "aesthetic concern": 9% vs. 3.6%

EVEN OUR UNFLUORIDATED KIDS HAVE VISIBLE PROOF OF HARM FROM FLUORIDE

Health Canada: Oral Health Component of the Canadian Health Measures Survey 2007–2009

- <Half of Canadians with fluoridated drinking water
- And yet: an EPIDEMIC of dental fluorosis
- 40% of children with 'non-normal' teeth
- 'Dean's Index': only children with ≥ 2 affected teeth counted as non-normal

- Dental fluorosis: expensive-to-fix. Cavities: cheap.

Fluoride Poisoning of Formula Fed Babies Units = mg of F / kg body weight / day

• EPA's Ref. Dose for Chronic Oral F Exposure, based on deleterious, objectionable dental fluorosis: 0.06

Region of Peel: Unconsented medication with toxic waste HFSA (fluoride, arsenic, lead, etc) NO WARNINGS

CDC Recommendation re: Toothpaste Fluoride Exposure for Children

Each gram of F'd toothpaste... contains approx. 1mg F

Pea-sized amount = approx. 0.25g toothpaste \rightarrow .25mg F

children <6 years, especially <2 years \rightarrow increased risk for fluorosis due to poor control of swallowing reflex

toothbrushing: ≤2 times a day, pea-sized amount, supervise, have them **SPIT OUT 0.25 mg F**

for children <2 years, consider the fluoride level in the community drinking water & other sources of fluoride

Health Canada Recommendation re: Toothpaste Fluoride Exposure for Children

- young children tend to swallow toothpaste → risk of dental fluorosis (caused by the fluoride)
- up to 3 years: IF the child is at risk of developing cavities, brush their teeth with rice sized grain of F'd toothpaste, 2x / day, if not at risk, use water
- 3 6 years: help them brush their teeth with a *pea-sized bit* of F'd toothpaste

Problem: Fluoridated Water

Peel's F'd water: 0.7 mg/L (aka .7 ppm) fluoride

 $1L \rightarrow 0.7 \text{ mg F}$ \therefore 350ml glass of water = 0.35L \rightarrow 0.35 x .7 mg F = 0.245 mg Fsame dose as pea-sized bit of F'd toothpaste SPIT OUT 0.25mg F in toothpaste but SWALLOW 0.25mg F in water repeatedly through the day **No Warning from Peel's Medical Officers**

Health Canada's 'Consideration' re: Fluoride Exposure for Adults

- High F levels over time \rightarrow skeletal fluorosis
- Average Canadian not exposed to high enough F levels
- Skeletal fluorosis = progressive disease, bones become brittle
- Mild cases \rightarrow pain, stiff joints
- Severe cases → difficulty moving, deformed bones, greater risk of fractures

REGION OF PEEL & "CLEAN WATER AGENCY":
