Thank you for your request for information dated 17 August 2021

Following a search of our records I write to advise you of the following responses to your questions.

"May I please know if Public Health Scotland has any actual material samples of purified SarsCoV2 virus and all related variants? I do not mean an in silico computer generated genome sequence. I mean actual material samples of purified viruses."

Response

Public Health Scotland (PHS) does not hold the information you requested. This is a formal notice that Section 17(1) - Information not held applies to your request, under the Freedom of Information Scotland Act (2002).

Additional Information

I can advise that it is not the remit of Public Health Scotland to undertake viral culture. Information is publicly available that the SARS-CoV-2 has been isolated and can be accessed on the Centers for Disease Control and Prevention website I include a web link here.

"If you do have these samples can you please tell me, what isolation and purification steps were taken to achieve this?"

Response

Public Health Scotland (PHS) does not hold the information you requested. This is a formal notice that Section 17(1) - Information not held applies to your request, under the Freedom of Information Scotland Act (2002).

Additional Information

It is not the remit of PHS to undertake viral culture. However information on the culture process of SARS CoV-2 is available to Public Health Scotland. Note that this is published by labs who carry out the process. I include the following web links

- WHO global research on Coronavirus

"If you do not have these do you know of any laboratories who do have them here in Scotland."

If our decision is unchanged following a review and you remain dissatisfied with this, you then have the right to make a formal complaint to the Scottish Information Commissioner within 6 months of receipt of our review response. You can do this by using the Scottish Information Commissioner's Office online appeals service at www.itspublicknowledge.info/Appeal. If you remain dissatisfied with the Commissioner's response, you then have the option to appeal to the Court of Session on a point of law.
