- Satisfy all 4 Koch's Postulates

Koch's postulates are the following:

- 1. The microorganism must be found in abundance in all organisms suffering from the disease, but should not be found in healthy organisms.
- 2. The microorganism must be isolated from a diseased organism and grown in pure culture.
- 3. The cultured microorganism should cause disease when introduced into a healthy organism.
- The microorganism must be reisolated from the inoculated, diseased experimental host and identified as being identical to the original specific causative

Thanks for your email. I am not certain that I completely understand your question, so feel free to come back to me with any further questions if needed.

ESR produces reports that summarises the descriptive epidemiology of tuberculosis (TB) notifications (disease and latent infections) in New Zealand on behalf of the Ministry of Health. These reports can be found on our website: https://surv.esr.cri.nz/surveillance/AnnualTBReports.php. All culture-based work on Tb is done at diagnostic laboratories, not at ESR.

This is the only work ESR does on Tb.

Here is the official information act request again (with additional information for clarity):

This is a formal request for access to general records, made under the Official Information Act.

The 4 Koch's Postulates are stated below:

- 1. The microorganism must be found in abundance in all organisms suffering from the disease, but should not be found in healthy organisms.
- 2. The microorganism must be isolated from a diseased organism and grown in pure culture.
- 3. The cultured microorganism should cause disease when introduced into a healthy organism.
- 4. The microorganism must be reisolated from the inoculated, diseased experimental host and identified as being identical to the original specific causative agent.

I am not seeking any records disputing Koch's postulates nor any records that attempt to justify the alleged Tuberculosis disease using unscientific methods. I am only seeking records that prove causation using valid scientific methods including valid control groups.
