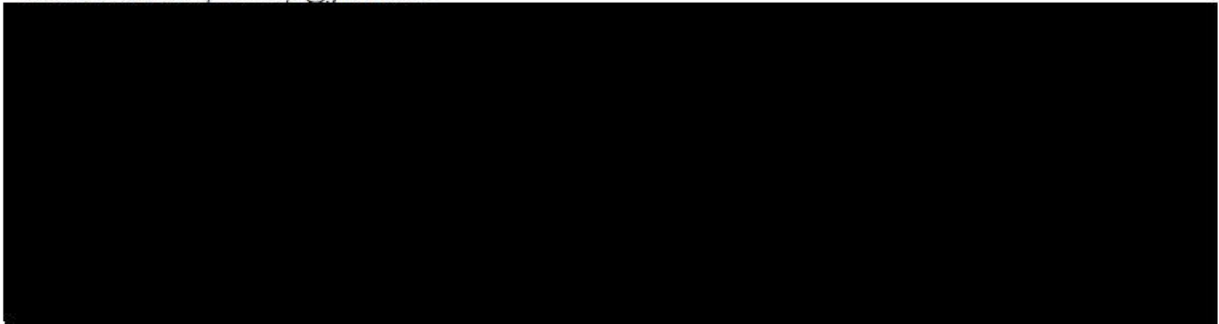
A test for a "virus" that has never been shown to exist obviously cannot be "legit" and is impossible to validate, so it seems the "existence" question would be the logical place to start.
