I received your voicemail on January 6, 2022 regarding security at 185 King Street. I can confirm for you that 185 King Street is a commercial condominium. Peterborough Public Health owns the condominium units which it occupies for operations, but the common areas for the building are controlled by the Condominium Board of which PPH is a member. Any decision about security for the entire building and hiring of security officers is done by the Condominium Board and implemented through the Property Manager for the Condominium, including protocols the security officers are instructed to follow. Peterborough Public Health is operating by appointment only at this time as we are following provincial guidance and therefore limiting the program services.

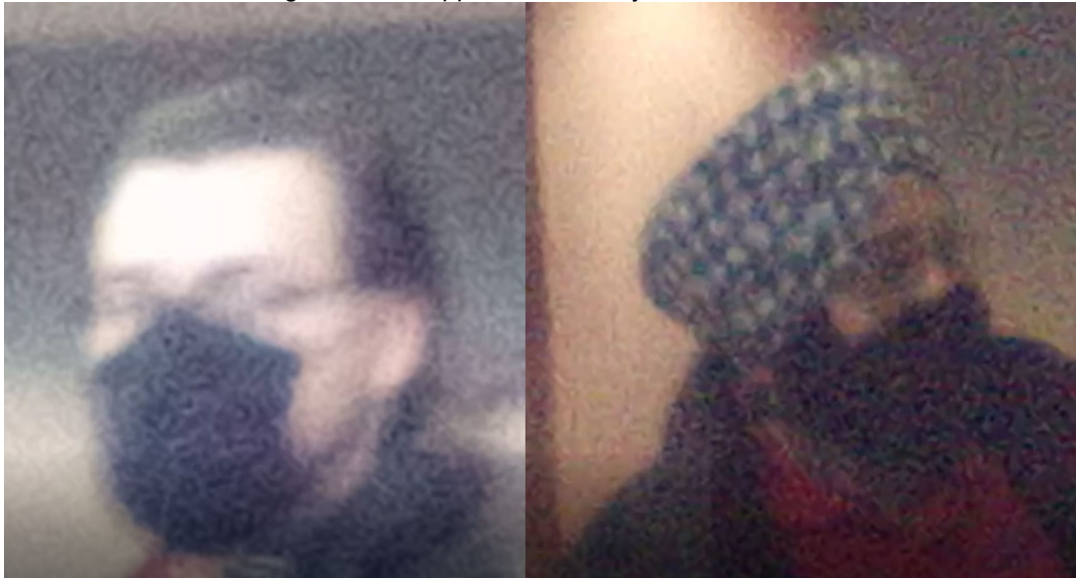
Mr. Stinson,
