Hi Sylvia,

I don't know if you're wildly incompetent and ignorant, or intentionally malicious, but you certainly managed to misrepresent myself and other members of this community in your "A Warm Welcome to Peterborough, Dr. Piggottt" hit piece.

I note that you never reached out to me before publishing said hit piece - despite the fact that I am the woman who served poor Thomas, and my name is provided at the beginning of the video you cite, and I am very easy to find online.
