Dear Tim,

This afternoon I dropped off a USB key containing the most important evidence in "occurrence PB22001282", at 500 Water Street.

Despite having brought this evidence to the attention of Scott Gilbert and Ryan Black 8 times (3 times via registered mail) starting in late January, this evidence is still not included in the "disclosure" package provided by "the Crown".

Gilbert and Black never responded to any of my communications.

I had to argue with the officers on duty at the station today to even accept this evidence. The first officer I spoke to initially tried to give it back to me.

In the end I was told that the evidence would be given to Ryan Black, despite my repeated advisements that Ryan apparently wants nothing to do with this evidence, and various contradictory statements were made as to whether or not the evidence will be added to the "occurrence" file (which I recorded on video).

Please confirm for me whether or not this key evidence in "occurrence PB22001282" will be added to the file and provided to "the Crown".

This evidence proves my innocence and shows that I should never have been charged, which was already apparent based on the other available evidence - hence Alicia McGriskin's refusal to lay charges even after she was pressured by Scott Gilbert and "Inspector" Lyons (as per her notes).
