I have been doing some preliminary negotiating with Steve Kirsch. I'd like to pin down the main debate issue. Is this language acceptable to everyone? If not please edit and distribute.

Debate question:

The published experiments on the isolation and in silico genome sequencing prove the existence of the SARS-CoV-2 "virus." True or False?

The purpose of this debate is to engage in a healthy scientific discussion. The spirit and philosophy of scientific inquiry demands attempting to refute all theories until it is clear they are irrefutable.
