This is our final response to your Freedom of Information Act (FOIA) request addressed to the Office of the Secretary at the United States Department of Health and Human Services (DHHS) dated May 23, 2022. On June 8, 2022, your request was forwarded to this office because of our responsibilities under the FOIA for the National Institute of Allergy and Infectious Diseases (NIAID), National Institutes of Health (NIH). You requested a copy of all studies and/or reports in the possession, custody or control of the Department of Health and Human Services describing the purification of the alleged "MonkeyPox Virus" (aka "Poxviridae Orthopoxvirus", directly from a sample taken from a diseased human, where the patient sample was not first combined with any other source of genetic material (i.e. monkey kidney cells aka Vero cells; fetal bovine serum).

The Division of Intramural Research, Division of Microbiology and Infectious Diseases, and Division of Clinical Research within the NIAID searched their files and no records responsive to your request were located. While we believe that an adequate search of appropriate files was conducted for the records you requested, you have the right to appeal this determination that no records exist which would be responsive to your request. Should you wish to do so, your appeal must be sent within ninety (90) days of the date of this letter, following the procedures outlined in Subpart F of the HHS FOIA Regulations
