I require access to general records, as per the *Freedom of Information Act*.

### Description of Requested Records:

All studies and/or reports in the possession, custody or control of Brian Schwartz, yourself, Jessica Hopkins, Samir Patel, Kirandeep Bains or Ontario Agency for Health Protection and Promotion that describe anyone on Earth finding and **purifying** any "**monkeypox virus**" directly from a sample (i.e. bodily fluid/tissue/excrement) taken from any diseased host (animal or human) where the sample taken from the host was not first combined with any other source of **genetic** material (i.e. a cell line; fetal bovine serum).

Please note that I do not require and do not want studies/reports where researchers failed to **purify** an alleged "virus" from the sample and instead:

- cultured something, and/or
- performed an amplification test (i.e. PCR), and/or
- fabricated a "genome", and/or
- produced electron microscopy images of unpurified things.

For further clarity, please note I am already aware that according to virus theory a "virus" requires host cells in order to replicate, and that a strict application of Koch's Postulates would not be possible even if theoretical "viruses" existed. I do not require records describing the **replication** of an alleged "virus" without host cells, or strict fulfillment of Koch's Postulates, or a suspected "virus" floating in a vacuum, or private patient records.

I simply require records that describe **purification** (**separation** from everything else in the sample that was taken from the host, as per standard laboratory practices for the purification of other very small things).

Also, should it prove impossible to provide any such study (since none exist and virology is not a science), then please provide or cite a study that, according to any of the people named above, proves the existence of any such "virus".

I require any study/report matching the above details, **authored by anyone, anywhere** since the alleged discovery of this alleged virus.

Dear Ms. Massey.

I am writing to you in connection with your request for access to information, for which the request fee was received on July 15, 2022. You requested:

*All studies and/or reports in the possession, custody or control of Brian Schwartz, [Colleen Geiger], Jessica Hopkins, Samir Patel, Kirandeep Bains or Ontario Agency for Health Protection and Promotion that describe anyone on Earth finding and **purifying** any "monkeypox virus" directly from a sample (i.e. bodily fluid/tissue/excrement) taken from any diseased host (animal or human) where the sample taken from the host was not first combined with any other source of **genetic** material (i.e. a cell line; fetal bovine serum).*

Please feel free to obtain copies through your local library or other organizations that provide access to scholarly work.

FIPPA section 50(1) allows you to appeal this decision, within 30 days, to the Information and Privacy Commissioner of Ontario (IPC). The IPC's contact information is:

# Notice of Trespass, CEASE AND DESIST

To Colleen Geiger, woman who acts as President and Chief Executive Officer Chief,  
Strategy and Stakeholder Relations, Research, Information and Knowledge

Colleen:

In the email dated July 25, 2022 from Ilone Harrison who acts as Privacy Officer, Public Health Ontario, to i christine (see further below and attached), this statement:

*"there are no records at PHO that are responsive to your request"*

is a confession that you and your colleagues at PHO have no scientific proof of the existence of the alleged monkeypox virus since purification is a necessary (but not sufficient) step in proving the existence of a virus (a replication-competent obligate intra-cellular parasite that transmits between hosts and causes disease via natural modes of exposure).

On August 4, 2021 Ilone issued to me a **confession** that you have no scientific proof of the existence of the alleged SARS-COV-2 either.

Immediately cease and desist all testing, claims and activity relating to the alleged monkeypox virus, as well as the alleged SARS-COV-2 and all other alleged viruses for which you have no records of purification from clinical samples.

You have until August 5, 2022 to rebut my claim with **written verified evidence**. If you fail to do so your tacit agreement will be in place that you are complicit in fraud, in violation of your oath and any fiduciary bonds and are not fit for "public office".
