**Appeal as per *Municipal Freedom of Information and Protection of Privacy Act (MFIPPA)* for assistance re: disclosure of monkeypox virus evidence
Peterborough Public Health File No. 2022-13**

Dear Ms. Kosseim,

I require your assistance obtaining access to general records from Peterborough Public Health, under what I hope are unusual circumstances involving a matter of public health significance.

In July 2022, I filed my first ever FOI request for records from Peterborough Public Health (PPH), via the City of Peterborough. On August 9, 2022, Larry Stinson acting as Director of Operations denied me access to the general records that form the basis of PPH's claim that monkeypox virus has been confirmed in Peterborough.

The justification Larry provided is an absurd and baseless assertion that "*this request is frivolous and/or vexatious, in that it is part of a pattern of conduct that amounts to an abuse of the right of access and interferes with the operations of Peterborough Public Health*". Previously he had done the same with a woman (Christine Massey) who lives in Peterborough and had sought the same records (PPH File No. 2022-08).

Therefore, I require your assistance in obtaining the required records and reducing the chance of a similar denial happening to others.

Enclosed are Larry's response and a letter from Christine. I cannot provide my request because I filed it via City of Peterborough's online portal; they then forwarded it to PPH.

Subject: MFIPPA appeal re Peterborough Public Health File No. 2022-13

I am writing to you to provide background information in order to assist with your assessment of an MFIPPA appeal from Darren [REDACTED]

Enclosed with this letter are records detailing my history of MFIPPA requests for records from Peterborough Public Health (PPH) and the responses I received; below is a brief summary.

1. May 16, 2021: request for records authored by anyone, anywhere describing anyone on Earth finding and purifying any "SARS-COV-2" from the bodily fluid/tissue of any diseased human.
See pages 1 – 6 of the enclosed "CM PPH FOIs" pdf file; PPH File No. 2021-05.
2. August 19, 2021: request for records authored by anyone, anywhere describing anyone on Earth finding and purifying any of the following alleged viruses from any clinical sample taken from any diseased human: HIV, Hepatitis B, Hepatitis C or SARS-COV-2.
See pages 7 – 12 of the enclosed "CM PPH FOIs" pdf file; PPH File No. 2021-11.
3. August 21, 2021: request for manufacturers' package inserts for all "COVID-19" injections/"vaccines" offered/promoted by PPH and/or the City of Peterborough.
The response letter dated August 25, 2022 from Larry Stinson, who acts as Director of Operations, stated that the insert for the Moderna "vaccine" was enclosed (it was a very large, folded piece of paper labelled "Intentionally left blank") and that inserts are not provided with the Pfizer "vaccine".

4. March 7, 2022: request for records authored by anyone, anywhere describing anyone on Earth finding and purifying any of the following alleged viruses from the bodily fluid of any diseased human: SARS, H5N1, H1N1, MERS or SARS-COV-2. Or, if they have no such records, any study that according to Thomas Piggott (who has acted as PPH Medical Officer of Health since December 2021) proves the existence of any of those alleged viruses.

5. April 4, 2022: request for records authored by anyone, anywhere describing anyone on Earth finding and purifying any "avian influenza virus" from the bodily fluid/tissue of any diseased human or animal. Or, if they have no such records, any study that according to Thomas Piggott proves the existence of said alleged virus.
See pages 25 – 31 of the enclosed "CM PPH FOIs" pdf file; PPH File No. 2022-04.
6. May 19, 2022: request for records authored by anyone, anywhere describing anyone on Earth finding and purifying any "monkeypox virus" from the bodily fluid/tissue of any diseased human or animal. Or, if they have no such records, any study that according to Thomas Piggott proves the existence of said alleged virus.
See pages 32 – 42 of the enclosed "CM PPH FOIs" pdf file; PPH File No. 2022-05.

My first 1ST, 2ND, 4TH, 5TH and 6th requests (for records of various "viruses" being found in and purified from bodily fluid/tissue) resulted in form-letter responses from Larry Stinson, each containing the exact paragraphs shown below:

Peterborough Public Health has no records in relation to your request. Local public health agencies in Ontario are responsible for adherence to the Health Protection and Promotion and implementation of the Ontario Public Health Standards and related protocols as set by the Ministry of Health. Scientific advice is provided by Public Health Ontario. We do not work directly with patient samples related to the viruses noted above or analysis of these samples.

7. June 26, 2022: request for the records that form the basis of Thomas Piggott and PPH's publicized claim that "monkeypox virus" has been confirmed in Peterborough. This request was unique from all previous requests as I did not seek records necessary for proving the existence of a virus, but merely the records relied upon by PPH in this circumstance. On June 30, 2022, Larry Stinson denied me access to these records and claimed that my requests in general are frivolous and/or vexatious, an abuse of right and interfering with the operations of PPH.

As you can see, I have filed 7 requests in total, between May 16, 2021 and June 26, 2022 - a period of 13.3 months - averaging approximately 1 request every 2 months. Larry Stinson responded with 5 form letters and 2 brief, unique letters.

Larry Stinson defied reason and reality on June 30, 2022 by claiming that my requests were frivolous and/or vexatious, had interfered with the operations of PPH and that my requests were an abuse in some way.

I was very distressed to see him provide the exact same response to Darren [REDACTED] and trust that you will assist Darren in obtaining the requested documents and by discouraging future nonsensical and unfair responses from Larry Stinson.

This is a formal request for access to general records, made under the *Municipal Freedom of Information and Protection of Privacy Act (MFIPPA)* due to COVID-19-related harassment of the public by agents of Peterborough Police Service and the City of Peterborough.

A failure to respond within 30 days as required under MFIPPA will be interpreted as "no records" and made public.

Description of Requested Records:

All studies and/or reports in the possession, custody or control of Dr. Rosana Salvaterra, or any Peterborough Public Health staff member responsible for "COVID-19" research/monitoring/decisions/policies/recommendations, describing the **purification** of any "**COVID-19 virus**" (aka "SARS-COV-2", including any alleged "variants" i.e. "B.1.1.7", "B.1.351", "P.1") (via maceration, filtration and use of an ultracentrifuge; also referred to at times by some people as "isolation"), directly from a sample taken from a diseased human, where the patient sample was not first combined with any other source of **genetic** material (i.e. monkey kidney cells aka Vero cells; fetal bovine serum).

Please note that I am not requesting studies/reports where researchers failed to **purify** the suspected "virus" from a patient sample and instead:

- cultured an unpurified sample or other unpurified substance, and/or
- performed an amplification test (i.e. a PCR test) on the total RNA from a patient sample or from a cell culture, or on genetic material from any unpurified substance, and/or
- fabricated a genome based on alignment/assembly/trimming/editing of thousands/millions of PCR-detected sequences in the total RNA from a patient sample or from a cell culture or from any unpurified substance, and/or
- produced electron microscopy images of unpurified things in a cell culture.

Clarification of Request

For further clarity, please note I am already aware that according to virus theory a "virus" requires host cells in order to replicate, and I am **not** requesting records describing the **replication** of a "virus" without host cells.

Further, I am **not** requesting records that describe a suspected "virus" floating in a vacuum; I am simply requesting records that describe its **purification (separation)** from everything else in the patient sample, as per standard laboratory practices for the purification of other very small things).

Please also note that my request includes any study/report matching the above description, for example (but not limited to) any published peer-reviewed study **authored by anyone, anywhere** since December 2019 and relied on by Dr. Rosana Salvaterra and/or Peterborough Public Health as evidence of a disease-causing "virus" circulating in humans.

Please note that despite the fact that **purification is an essential** (but not sufficient) step in proving the existence of a disease-causing "virus", as of today 58 institutions globally have all failed to provide or cite any such records, therefore to my knowledge no such records exist and if they do exist I cannot access them until I am provided a citation or URL.

Therefore in the interest of transparency and in accordance with the purposes of *MFIPPA*, if any records match the above description of requested records and are currently available to the public elsewhere, please provide enough information about each record so that I may identify and access each one with certainty (i.e. title, author(s), date, journal, where the public may access it). Please provide URLs where possible.

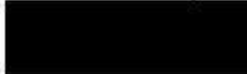



Symptoms and Testing:

With the recent surge in COVID-19 cases and contacts, PPH may not be able to contact all COVID-19 cases within 24 hours from when the positive test was reported. Similarly, PPH is focusing on identifying high-risk contacts in high risk settings and will not be able to identify every high risk contact in the broader community.

We are asking residents to assist us in keeping the community safe and use their best judgement when it comes to self-isolation and getting tested for COVID-19.

Symptoms of COVID-19 can vary from person to person and may vary in different age groups. **Seek immediate medical attention if you are experiencing serious symptoms such as difficulty breathing or chest pain or have symptoms and are at high-risk of severe illness.** Use the [Self-Assessment Tool](#) if you have any [symptoms of COVID-19](#) or feel you may have been in contact with a person who has COVID-19.

The most common symptoms of COVID-19 are:

- Fever (37.8°C or higher) and/or chills
- Cough (that is new or worsening)
- Shortness of breath
- Decrease or loss of taste or smell

Other symptoms of COVID-19:

- Sore throat or difficulty swallowing
- Runny or stuffy nose
- Headache (unusual or long lasting)
- Extreme tiredness or lack of energy
- Muscle aches or joint pain
- Nausea, vomiting, and/or diarrhea

The following guidance will provide direction for isolation and identifying high risk contacts:

Self-isolation:

You are required to stay home and self-isolate if you **test positive**, or have **1 or more** of the **most common** symptoms or **2 or more** of the **other symptoms**.

If you are:

- 11 years old or younger
- OR are [fully vaccinated](#)

You must self-isolate for 5 days from when symptoms start and stay in isolation until symptoms have been improving for 24 hours (or 48 hours after nausea, vomiting and/ or diarrhea symptoms), whichever is longest.

If you are:

- 12 years old or older
- AND unvaccinated or partially vaccinated
- OR immune compromised

You must self-isolate for 10 days from when symptoms start and stay in isolation until symptoms have been improving for 24 hours (or 48 hours after nausea, vomiting, and/or diarrhea symptoms), whichever is longest if:

If you only have **1** of the **other symptoms** you must stay home for **at least 24 hours** until symptoms are improving (48 hours for nausea, vomiting and/or diarrhea) and as long as you do not develop any new symptoms.

Your isolation period begins the day after you noticed your symptoms or the day after you received a positive test result – whichever came first. The day you first noticed symptoms or took the test is considered day zero.

Alert Contacts:

Alert your household contacts and other close contacts that they may need to self-isolate and provide them the link to <http://www.ontario.ca/exposed>. A close contact is anyone who had contact with you within the 48 hours before your symptoms began and until you started self-isolating AND were within two metres for a total of at least 15 minutes without masking, distancing, or using of person protective equipment.

Dear Ms. Massey:

In response to your request under the *Municipal Freedom of Information and Protection of Privacy Act (MFIPPA)* for:

"All studies/reports in the possession, custody or control of Thomas Piggott or anyone else acting at Peterborough Public Health, that describe anyone on Earth finding and purifying any "monkeypox virus" directly from the bodily fluid/tissue/excrement of any diseased host (animal or human) where the bodily fluid/tissue was not first combined with any other source of genetic material (i.e. a monkey cell line; fetal bovine serum).

Please note that I do not require and do not want studies/reports where researchers failed to purify an alleged "virus" from a diseased host's bodily fluid/tissue and instead:

- cultured an unpurified substance (i.e. bodily fluid) in a malnourished cell line, added toxic drugs, watched for cytopathic effects and called that "virus isolation", and/or*
- performed an unreliable amplification test (i.e. a PCR test), that can only detect sequences and not "viruses", on the soup of genetic material extracted from a host's bodily fluid or from cell culture supernatant, and/or*
- fabricated an in silico (computer) sequence (fake "genome") from millions of sequences unreliably detected in the soup of total nucleic extracted from a host's bodily fluid or from a cell culture, and/or*
- produced electron microscopy images of unpurified particles in a cell culture.*

Clarification of Request

For further clarity, please note I am already aware that according to virus theory a "virus" requires host cells in order to replicate, and that a strict application of Koch's Postulates would not be possible even if theoretical "viruses" existed. I do not require records describing the replication of an alleged "virus" without host cells, or fulfillment of Koch's Postulates, or a suspected "virus" floating in a vacuum, or private patient records.

I simply require records that describe purification (separation from everything else in the bodily fluid/tissue, as per standard laboratory practices for the purification of other very small things).

I require any study/report matching the above details, authored by anyone, anywhere, since the alleged discovery of these alleged "viruses".

In the interest of transparency and in accordance with the purposes of MFIPPA, if any records match the above description of requested records and are currently available to the public elsewhere, please provide enough information about each record so that I may identify and access each one with certainty (i.e. title, author(s), date, journal, where the public may access it). Should it prove impossible to provide any such study (since none exist and virology is not a science), then please provide or cite a study that, according to Thomas Piggott, proves the existence of any such "virus".

Peterborough Public Health has no records in relation to your request. Local public health agencies in Ontario are responsible for adherence to the Health Protection and Promotion and implementation of the Ontario Public Health Standards and related protocols as set by the Ministry of Health. Scientific advice is provided by Public Health Ontario. We do not work directly with patient samples related to monkey pox virus or analysis of samples.
