Hi Christine:

Yes, would love to chat on Zoom. As far as your question on publishing the documentation, our lab, actually, one of our post docs who's dealing with the publishing of the study reached out to the Danish Medical Journal (our 21st attempt) to publish, but they rejected the draft in late October 2021. At this point we're looking at publishing the study privately. We have a publisher that has "conditionally" accepted to publish out of Texas. We will know in the next 2 months if this pans out.

As far as my schedule goes, I'm planning on a road trip to Yellowstone early next week to get away from Santa Barbara and as a bonus, have a closer look at the Prismatic pools there which grow colonies of a bacteria called *Thermus aquaticus* which in turn produces Taq polymerase, the enzyme that is used as a protein de-naturing component in the PCR test for the "FICTION" virus. I don't think most people who visit the park even know what they're looking at.

As an ecologist, when Tom Brock first visited Yellowstone National Park in the mid 1960's, he saw the colorful hot springs in a different way than most. He was stunned by the microbes present there that no one seemed to know anything about. His research that followed uncovered a previously unknown characteristic of life — the ability for bacteria to live in near-boiling water. The existence of these organisms would later lead to groundbreaking discoveries in the fields of microbiology and genetics.




I hope this finds you well. You've been busy with several new interviews, I have some catching up to do:)

The focus of my FOI newsletters is very tight for that exact reason. I don't want to put out claims that I'm not certain I can back up.


I lost my job in 2020 for refusing to wear a mask and lived in my mother's unfinished basement for the last 1.5 years because of my
