

Year 8 Sexual Assault in Isle of Man Schools by HPV Vaccines - September 2022

This document is best read alongside: Notice of HPV Vaccine Carnage of Wednesday 14th September 2022, which exposes dates of planned assaults on the ovaries of Manx girls and the testicles of Manx boys in five Isle of Man senior schools. These documents should be read in conjunction with the faked HPV vaccine clinical 'trials' which used comparators, not benign placebo's - so that countless harms could be hidden.

On Thursday 15th September 2022 an attempt was made to hand the above Notice to the reception staff at Ramsey Grammar School. Three ladies present in the office refused to accept it, or to give us their names. Immediately following the above attempt to serve Notice, we (Courtenay and Al') went to Ramsey Police Station where we met Alison McKay Mills and Alex Mealin (# 210) at the reception window, where we attempted to hand over the Notice, which was refused. Alison said: "you won't be reporting an incident", pushing the window closed, while Alex Mealin uplifted the handle - to end the attempted 'meeting'.

On seeing Alison the next day, 16th September 2022, at 17.40 in Parliament Square, Ramsey, knowing that she wasn't on duty - I then called at Ramsey Police Station to see if anyone was doing theirs. Fortunately, I encountered Andy Culshaw (#949) who signed a receipt for the Year 8 HPV Vaccine Notice to be handed on to Alex Mealin - this was witnessed by Stephen Nathan (#940) at 17.43 hours. Later on, at 19.04, on Friday 16th September 2022, I returned to Ramsey Police Station when I presented Andy Culshaw my autographed books to him, along with four documents for completeness: 1) 'Year 8 HPV Notice', 2) 'Crime report for 'covid' jabs', 3) 'Dr Mengele i Presume' and 4) 'No Virus Mann'. Stephen Nathan witnessed this.

This vaccine carnage and fraud was foretold - as it is nearly two years since Sarah Findlater, Head of Ramsey Grammar School was named (page 165) in The Covid Con; A Wake, by courtenay-adam-lawrence.

Vaccine assaults only take place with assumed & presumed parental consent, which, unwittingly, you give by 'registration'. To obtain remedy and to avoid medical rape of the property of your girls and boys you must know 'equity does not aid a volunteer' in court. More so, as vaccines have no legal liability attached...

Remedy:

- 1) As a 'PCR test Manx expert' demand Dr Rachel Glover signs that 'HPV exists and that the isolated, purified, whole genome HPV 'virus' causes cervical cancer in girls and other cancers in boys'.
- 2) Demand that any man or woman administering (toxic) vaccines is liable in their private capacity.

On 17th February 2018, I met Dr Diane Harper in Thessaloniki, Greece, where she presented at the 8th Hellenic HPV Symposium. Dr Harper was lead scientist on the 'Gardasil' by Merck, HPV vaccine 'trials'. (She **previously** received substantial funding from Merck... and GSK...). During our 3.5 hour lunch she confirmed she had only been allowed to present in Greece (after an eight year censure for questioning safety) if... she assured the organisers '**she would not mention HPV vaccine harms**'.

On Tynwald Day (5th July 2019) **I was arrested** at Tynwald Hill **while wearing an 'HPV Vaccine Deaths' yellow vest**, so was prevented from presenting my HPV vaccines petition for redress. Also present (at my invitation) on Tynwald Day 2019 was US lawyer Kim Mack Rosenberg, co-author of the book: The HPV Vaccine On Trial - one of five international HPV vaccine harms books.

On Tynwald Day (6th July 2020) **I was again arrested**, this time at Ballacraigne crossroads **while wearing an 'HPV Vaccine Deaths' yellow vest**.

There has been lock-step **refusal for any open public debate** by Manx GP Dr Helen Freer (despite her writing about HPV vaccines 'I fear we are sitting on a timebomb'). Dr Alex Allinson also refuses debate, so did Dr Henrietta Ewart (since 2017), as the former Isle of Man Director of Public Health.
