Dear Larry,

I require you to provide me records as per your duty under the Municipal Freedom of Information and Protection of Privacy Act (MFIPPA).

#### **Application Fee:**

The \$5 application fee will be delivered to the address listed above.

#### **Background:**

Under your direction, parents in Peterborough were recently given letters indicating that children would be injected in schools with so-called "vaccines", allegedly to protect them from various alleged "viruses".

#### **Description of Requested Records:**

All studies and/or reports that scientifically prove the existence of the alleged "viruses" for which you and Thomas Piggott intend to have children "vaccinated".

### Scientific proof is NOT

- Opinion
- Assumption
- Speculation
- Review papers
- Descriptive papers

### Scientific proof requires

- · An independent variable
- Use of the scientific method
  - Repeatable and falsifiable hypotheses that have been tested using valid, controlled experiments where only 1 variable (the independent variable) differs between the experimental and control groups
  - · In this case, the independent variable would be the presence/absence of purified particles that are suspected of being a "virus", obtained from the bodily fluid/tissue/excrement of alleged "hosts"
  - · Consistent results from valid, controlled experiments (i.e. identical "genomes", consistent causation of the relevant disease via natural modes of exposure)

Records that do not describe the testing of falsifiable, repeatable hypotheses using valid controlled experiments regarding the existence of an alleged "virus" (meaning the existence of the alleged particle and its alleged causation of disease) are disqualified from my request.

Virus = infectious, replication-competent, obligate intracellular parasite that consists of a genome and a proteinaceous shell that is encoded by the genome, that spreads from host to host causing disease via natural modes of exposure.

#### Request to be forwarded as per section 25 (1) of MFIPPA:

Previously you have indicated to me that you rely on claims made by people who act for other institutions when it comes to alleged "viruses". Therefore, in accordance with the legislation, forward this FOI to the appropriate institution(s) for all of the alleged "viruses" for which you and Thomas Piggott do not have scientific proof, and notify me of such.

"Where an institution receives a request for access to a record that the institution does not have in its custody or under its control, the head shall make all necessary inquiries to determine whether another institution has custody or control of the record, and where the head determines that another institution has custody or control of the record, the head shall within fifteen days after the request is received, (a) forward the request to the other institution; and (b) give written notice to the person who made the request that it has been forwarded to the other institution."

If any records match the above description of requested records and are currently available to the public elsewhere, please provide enough information about each record so that I may identify and access each one with certainty (i.e. title, author(s), date, journal, where the public may access it). Please provide URLs where possible.

In response to your request under the Municipal Freedom of Information and Protection of Privacy Act (MFIPPA) for:

"All studies and/or reports that scientifically prove the existence of the alleged "viruses" for which you and Thomas Piggott intend to have children "vaccinated".

Peterborough Public Health has reviewed this request and considered it in the context of several other requests that you have submitted over the past few years. The decision has been made that this request is frivolous and/or vexatious, in that it is part of a pattern of conduct that amounts to an abuse of the right of access and interferes with the operations of Peterborough Public Health.

I am responsible for the decision to deny this access to information. You may ask for a review of this decision within 30 days of receiving this letter by writing to: The Information and Privacy Commissioner/Ontario, 2 Bloor Street East, Suite 1400, Toronto, Ontario, M4W 1A8, Tel.: 1-800-387-0073.

If you decide to request a review of this decision, please provide the Commissioner's office with the following: the file number listed at the beginning of this letter; a copy of this decision letter; a copy of the original request for information you sent to our institution; and the reasons for your appeal.

In addition, you must send an appeal fee to the Commissioner's office. The appeal fee for this request for information is \$25.00. Please include the fee with your letter of appeal. Appeal fees should be in the form of either a cheque or money order, payable to the minister of Finance.
