Dear Jessica Clark:

RE: Your Access Request dated September 23, 2022 - Our File FOI 22-39

This is further to your access request under the Municipal Freedom of Information and Protection of Privacy Act (the "Act") dated September 23, requesting the following:

All studies and/or reports in the possession, custody or control of Dr. Colin Q-T Lee or Dr. Charles Gardner or Dr. Sue Surry, or Dr. Lisa Simon, or any Simcoe Muskoka District Health Unit staff member responsible for "clinic inspections", or any member of Simcoe Muskoka District Health Unit "infectious/transmissible disease" leadership, describing the purification (i.e. via filtration, ultracentrifugation and chromatography) of any "HPV" aka "human papilloma virus" or of any "Hepatitis B virus" directly from a sample taken from a diseased human where the patient sample was not first combined with any other source of genetic material (i.e. a human or animal cell line; fetal bovine serum).

Please note I am not requesting studies or reports where researchers failed to purify the suspected "virus" but instead:

- Cultured an unpurified sample or other unpurified substance and/or
- Performed an amplification test (ie. PCR test) on all the RNA from a patient sample or from a cell culture, or on genetic material from any unpurified substance, and/or
- Sequenced the total RNA from a patient sample or from a cell culture or from any unpurified substance and/or
- Produced electron microscopy images of unpurified things.

I am simply requesting records that describe purification (separation from everything else in the patient sample, as per standard practices for the purification of other small things.)

Please note that my request is not limited to records that were authored by Simcoe Muskoka Health Unit or that pertain to Simcoe Muskoka Health Unit. Rather, my request includes any record matching the above description, for example (but not limited to) any published peer reviewed study authored by anyone, anywhere, that has been downloaded or printed by Administration or Staff at Simcoe Muskoka Health Unit and relied on as evidence of a disease causing "virus."

If any records match the above description of requested records and are currently available to the public elsewhere, please provide enough information about each record so that I may identify and access each one with certainty.

Records related to Human Papilloma Virus and Hepatitis B testing methods are not in the custody or control of the Simcoe Muskoka District Health Unit, our recommendation would be to inquire with the Ministry of Health of Ontario, Public Health Ontario, and Health Canada to seek information regarding these specific laboratory methodologies.



RE: Your Access Request dated September 23, 2022 - Our File FOI 22-39

This is further to your access request under the Municipal Freedom of Information and Protection of Privacy Act (the "Act") dated September 23, requesting the following:

All studies and/or reports in the possession, custody or control of the Simcoe Muskoka District Health Unit describing the purification (i.e. via filtration, ultracentrifugation and chromatography) of any "virus" addressed by any "vaccine" on either the childhood or adult Canadian "immunization" schedule, directly from a sample taken from a diseased host, where the sample was not first combined with any other source of genetic material (i.e. a cell line; fetal bovine serum). Please note that I am not requesting studies/reports where researchers failed to purify the suspected "virus" and instead: cultured something, and/or performed an amplification test (i.e. PCR), and/or fabricated a "genome", and/or produced electron microscopy images of unpurified things. I am already aware that according to virus theory a "virus" requires host cells in order to replicate. I am not requesting records describing the replication of a "virus" without host cells, or records that describe a suspected "virus" floating in a vacuum, or a strict fulfillment of Koch's Postulates, or private patient records. I simply request records that describe "its" purification (separation from everything else in the patient sample, as per standard laboratory practices for the purification of other very small things). Please note that my request includes any study/report matching the above description, authored by anyone, anywhere. If any records match the above description of requested records and are currently available to the public elsewhere, please provide enough information about each record so that I may identify and access each one with certainty (i.e. title, author(s), date, journal, where the public may access it). Please provide URLs where possible.

Records related to virus addressed by any vaccine testing methods are not in the custody or control of the Simcoe Muskoka District Health Unit, our recommendation would be to inquire with the Ministry of Health of Ontario, Public Health Ontario, and Health Canada to seek information regarding these specific laboratory methodologies.
