Scientific proof is NOT

opinions,
speculation,
review papers, or
descriptive papers;

Scientific proof requires

use of the scientific method,
an independent variable,
repeatable and falsifiable hypotheses that have been tested using valid, controlled experiments where only the independent variable differs between the experimental and control groups,
consistent results from the valid, controlled, repeated experiments (i.e. identical "genomes", consistent in vivo effects);

in this case, the 1 manipulated independent variable would be the presence/absence of purified particles suspected of being a "virus";

records that do **not** describe the valid, logical and repeatable testing of falsifiable hypotheses regarding the existence of the alleged "virus" are not useful and not wanted;

Publicly available records:

if any records match the above description of requested records and are currently available elsewhere, provide enough information about each one so that i may identify and access each one with certainty (i.e. title, author(s), date, journal, where the public may access it); provide URLs where possible;

It is the decision of the University that FIPPA does not apply to the requested records, because you have requested records related to research conducted by employees or persons associated with an educational institution or hospital, which are excluded from FIPPA pursuant to section 65(8.1).

Consistent with FIPPA section 65(9), the subject-matter of the research is infectious diseases.

Statistics about the University’s engagement in research relating to COVID-19, including the subject matters set out in your request and associated funding, is publicly available at <https://data.utoronto.ca/performance-indicators/> (published May, 2021) as part of the University’s annual Performance Indicators’ Report.

FIPPA section 50(1) allows you to appeal any decision made by the University, within 30 days, by notifying the Information and Privacy Commissioner/Ontario (the IPC). Therefore, you may appeal this decision within thirty days of the date of this letter. The IPC’s contact information is as follows:

Your letter states:

It is the decision of the University that FIPPA does not apply to the requested records, because you have requested records related to research conducted by employees or persons associated with an educational institution or hospital, which are excluded from FIPPA pursuant to section 65(8.1).

Who is "the University"?

Please remind "the University" that my FOI is not restricted to "*records related to research conducted by employees or persons associated with an educational institution or hospital*", and neither FIPPA nor common sense prohibit the release of the requested records regardless of who they are or aren't associated with.

And that if the required records don't actually exist, then section 65(8.1) is irrelevant and section 29 requires an admission of non-existence

Your letter implies that the required records do exist, which contradicts the methodologies used in the published literature and the worldwide search for such records, as stated in my notarized declaration, attached. If such records actually do exist, they need to be released to the public immediately.

So this decision letter is going to reflect very poorly on "the University".

The IPC is essentially now useless, having closed their office on the premise of a hypothetical virus and admittedly being too incompetent to do their work remotely, so I won't bother with a complaint. I will simply publish this response and add it to the lists of failures to provide a shred of science by institutions worldwide.
