The purpose of this letter is to obtain clarification of the status of the matter before the ONTARIO COURT OF JUSTICE, referred to as COURT OF JUSTICE File # 3311 998 22 33100161" and/or "3311998223310016101" and/or "REGINA v. MASSEY, CHRISTINE" and variations thereof, involving PETERBOROUGH POLICE SERVICE occurrence #: PB22001282.

Please advise as soon as possible if this file is still being prosecuted by the CROWN.

If the file has been closed, or charges are not being prosecuted, I request that you have the related content on the www.justiceservices.jus.gov.on.ca website removed forthwith, as it harms my reputation.

I also request a copy of the records showing the status of the file and the charges.

Background:

On June 23, 2022, Paul Murray, representing the CROWN, stated that the CROWN intends to call 2 people who work for PETERBOROUGH POLICE SERVICE as witnesses at a trial, and did not specify those 2 people.

On June 30, 2022, Stuart Konyer acting as Judge urged Joleen Hiland, representing the CROWN, to provide the outstanding list of people she intends to call as witnesses. Joleen Hiland responded "Yes, Your Honour", but the CROWN has not done so. The transcript of the hearing is available on request.

Over a year ago, by email dated July 13, 2022 to Paul Murray and Joleen Hiland and other individuals who I was told represent the CROWN on this file, I specifically asked if they are pursuing the charges through the courts. I also asked why they had not sent me the list. I asked that if they are not pursuing the charges, they kindly advise me so that I could get on with my life, and received no response.

Again, on July 30, 2023, by email to Paul Murray and Joleen Hiland, I expressed uncertainty regarding the status of this file, and asked why they had not sent me the list. I have received no response.

On June 30, 2022, Stuart Konyer also scheduled a trial for December 5, 2023, at which time almost 2 years will have passed since charges were laid on January 20, 2022.

The CROWN has not provided me the witness list, or certain other documents, or the particulars that I need in order to properly comprehend the CROWN's position and prepare for a trial. I have a list of outstanding disclosure issues, available upon request.

Also, attempts, both in person and via email, to obtain the related court documents that are normally available to the public have been unsuccessful. For example, my email to Peterborough.Court.docs@ontario.ca on March 2, 2023 has gone unanswered.

On August 24, 2022, September 3, 2022 and October 3, 2022 a researcher, William Huston, also attempted via emails to Peterborough.Court.docs@ontario.ca and Peterborough.OJ.courts@ontario.ca to obtain said court documents and was not provided any or given any reason for withholding them.

I am happy to receive the requested information either by email or regular mail, at the addresses below, and ask that my requests get immediate attention given that 18 months have already passed since the charges were laid, and the urging of Stuart Konyer acting as Judge has so far been ignored by the CROWN to my detriment.

This letter is a follow up to my letter dated August 8, 2023, that was delivered via registered mail (RN 688 754 013 CA) on August 9, 2023, as I have not received a response.

For your convenience, I will reiterate outstanding issues.

I ask for clarification of the status of the matter before the ONTARIO COURT OF JUSTICE, referred to as COURT OF JUSTICE File # 3311 998 22 33100161" and/or "3311998223310016101" and/or "REGINA v. MASSEY, CHRISTINE" and variations thereof, involving PETERBOROUGH POLICE SERVICE occurrence #: PB22001282.

Please advise as soon as possible if the CROWN still intends to prosecute.

If no charges are being prosecuted, I request that you have the related content on the www.justiceservices.jus.gov.on.ca website removed forthwith, as it harms my reputation.

I am happy to receive the requested information either by email or regular mail, at the addresses below, and ask that my request gets immediate attention given that 18 months have already passed since the charges were laid - which is generally considered an unreasonable delay - and the urging of Stuart Konyer acting as Judge, described below, has so far been ignored by the CROWN to my detriment.

Background:

On June 23, 2022, Paul Murray, representing the CROWN, stated that the CROWN intends to call 2 people who work for PETERBOROUGH POLICE SERVICE as witnesses at a trial, and did not specify those 2 people.

On June 30, 2022, Stuart Konyer acting as Judge urged Joleen Hiland, representing the CROWN, to provide the outstanding list of people she intends to call as witnesses. Joleen Hiland responded "Yes, Your Honour", but the CROWN has not done so. The transcript of the hearing is available on request.

On August 10, 2023, I telephoned the CROWN's office in Peterborough and a woman who identified herself as "Lisa" refused to leave a message for Paul Murray or Joleen Hiland on my behalf.

On June 30, 2022, Stuart Konyer scheduled a trial for December 5, 2023, at which time almost 2 years will have passed since charges were laid on January 20, 2022.

The CROWN has still not provided a claim of trespass from any man or woman, or even a bill of particulars or an "Information in Form 2" as prescribed in the Criminal Code, or the list of people who they intend to call as witnesses.

I cannot comprehend the CROWN's position and/or prepare for a trial, without being provided a coherent cause of action, and I have never agreed to a trial or to perform labour without compensation. I have previously notified Paul Murray, agents and principles of this fact on multiple occasions.

Subject: matter allegedly before Ontario Court of Justice, File number 3311 998 22 33100161

This is a follow up to my letter dated August 8, 2023 that was delivered via registered mail (RN 688 754 013 CA) on August 9, 2023, and to my letter dated August 25, 2023 that was delivered via registered mail (RN 688 754 000 CA) on August 28, 2023. I have not received a response from you.

Once again, I ask that you clarify the status of a matter. This matter has been pursued by people who I believe act under your control.

The matter in question is allegedly before the Ontario Court of Justice. It is referred to as File # 3311 998 22 33100161" and/or "3311998223310016101" and/or "REGINA v. MASSEY, CHRISTINE" and variations thereof. It involves Peterborough Police Service occurrence #: PB22001282.

Twenty months ago, on January 20, 2022 Ryan Black acting for Peterborough Police Service handcuffed and detained me against my will. He told me I was "charged" under the "Criminal Code". He gave me papers suggesting that "You must attend court" on "the 16th day of February, 2022" in "Courtroom No. 2" at "70 Simcoe Street, Peterborough, Ontario". 70 Simcoe Street, Peterborough, Ontario is the address of Ontario Court of Justice. On February 16, 2022 in Courtroom 2 there was a session of Ontario Court of Justice. Mark Donohue acted as "Justice of the Peace".

No one has given/served me a claim of trespass or "statement of claim" from any man or woman, or a bill of particulars. I have only been given what appear to be internal corporate forms. One such form is labeled as "Form 2 Information". It is missing elements of the "Form 2" shown in the "Criminal Code". This "Form 2 Information" does not indicate that it was sworn before anyone acting for the Ontario Court of Justice.

I have sent many communications to the court asking for all related files/records. No one acting for the court or Peterborough Police Service or "REGINA" has given me any papers or electronic records bearing the name of the court "Ontario Court of Justice".

People acting for "the Crown", the court and Peterborough Police Service have given me papers and/or electronic records bearing the name of what appears to be an imaginary court called "Ontario Court of the Justice". This includes a paper and electronic record labeled as "WARRANT FOR ARREST".

I have been served/provided no summons, notices or records/files/documents that are addressed to me in relation to this matter. I have only been given what appear to be internal corporate forms. *They are available upon request. Christa*

I have had no communications directly with anyone named "REGINA".

"The Crown" has not given me the list of people who they intend to call as witnesses at a trial.

I cannot comprehend the position of "REGINA" / "the Crown". I cannot prepare for any court "appearances" without being served a coherent claim describing a cause of action.

I have never agreed to a trial or any future "appearances". All of my past "appearances" were coerced special appearances under threat of "arrest" should I "fail to appear". I have never agreed to perform labour without compensation. I have never given jurisdiction or power of attorney to anyone. I have never agreed to contract or joinder in this matter. I have previously notified Paul Murray, other agents, and principal(s) of these facts on multiple occasions and received no response. My previous notifications have included my fee schedule, which is subject to change without notice.

On September 19, 2023, Paul Murray allegedly representing "REGINA" sent an email (see enclosed) to one of my email addresses. He wrote: "I have brought the information forward to September 26, 2023 in Courtroom #3 at 70 Simcoe. At that time, the Crown will ask the Court to impose a stay of proceedings and as a result the matter will be concluded. You are of course welcome to attend on that date, but if you do not I will confirm with you the matter has been completed." Paul did not attach an application in Form 1. No one has ever served me an application in Form 1. I have received no summons from the court relating to September 26, 2023 or any other date.

Paul Murray has shown himself to be an unreliable source of information in the past. For example, on March 23, 2022, at 10:02 am I received an email from Paul Murray containing at least 2 false statements. He stated that "Shawna McCurdy is a civilian member of the police service". This was false. He stated "you are not charged with assault, but rather with criminal harassment and extortion of a medical professional". This was false.

Therefore I ask that you honourably clarify the status of this matter. Is this matter before Ontario Court of Justice? If so: 1) Why are there no records bearing the name of the court? 2) Why do some records including the "warrant" have the name of an imaginary court? 3) Why have I not been served/provided any claim to respond to? 4) Why does the "Form 2 Information" not indicate that it was sworn before someone acting for the court? 5) Why did Stuart Konyer, acting under your control as Judge, schedule a trial for December 5, 2023 – a

date almost 2 years after the "charges" were laid - when anything more than 18 months between "charges" and end of arguments at trial is considered an unreasonable delay? 6) Would it be fair or reasonable or lawful to have this matter merely "stayed", with a "charge" and the possibility of a trial left dangling over my head for another year? 7) Am I lawfully obligated to attend court on September 26, 2023 or on any other date? If your answer is "yes": on what grounds? 8) On September 26, 2023, will anyone acting for "REGINA" / "the CROWN" and/or the court be permitted to keep this matter hanging over my head any longer? 9) Have you viewed the 2 publicly available videos that were filmed on Thomas Piggott's porch and show what actually did and did not happen on the evening of January 19, 2022? 10) Will you ensure that the false "charge(s)" are withdrawn right away so that I can get on with my life?

If this matter is not before Ontario Court of Justice: how could "the Crown" ask the Court to impose a stay of proceedings?

If no "charge" is being prosecuted, I ask that you have the related content on the www.justiceservices.jus.gov.on.ca website removed immediately, as it damages my reputation.

Please respond at either of the addresses below. I ask that you give this matter immediate attention given that 20 months have already passed since I was handcuffed and told that charges were laid, and that the urging of Stuart Konyer acting as Judge, described below, has so far been ignored by the people acting as "CROWN" to my detriment.

Background re "witness list":

On June 23, 2022, Paul Murray, alleging to represent "the Crown", stated that "the Crown" intends to call 2 people who work for the service corporation Peterborough Police Service as witnesses at a trial, and did not specify those 2 people.

On June 30, 2022, Stuart Konyer acting as Judge urged Joleen Hiland, allegedly representing "the CROWN", to provide a list of people she intends to call as witnesses. Joleen Hiland responded "Yes, Your Honour", but no such list has been provided to me. The transcript of the hearing is available on request.

Over a year ago, by email dated July 13, 2022 to Paul Murray and Joleen Hiland and other individuals who allege to represent "the CROWN" on this matter, I asked whether they are pursuing the alleged "harassment charge" through the court and why they had not sent me the list. I asked that if they are not pursuing the "charge" they kindly advise me, but received no response.

Again, on July 30, 2023, by email to Paul Murray and Joleen Hiland, I asked why they had not sent me the list. I received no response.

On August 10, 2023, I telephoned "the CROWN's" office in Peterborough. A woman who identified herself as "Lisa" refused to leave a message for Paul Murray or Joleen Hiland on my behalf. She hung up on me.

On June 30, 2022, Stuart Konyer scheduled a trial for December 5, 2023, at which time almost 2 years will have passed since "charges" were allegedly laid on January 20, 2022.
