Subject: REGINA v. MASSEY, CHRISTINE, R. v MASSEY, CHRISTINE, Case Number
3311998223310016101

This is a follow up to my letter dated August 8, 2023 that was delivered via registered mail (RN 688 754 013 CA) on August 9, 2023, and to my letter dated August 25, 2023 that was delivered via registered mail (RN 688 754 000 CA) on August 28, 2023, and to my letter dated September 21, 2023 that was delivered via registered mail (RN 743 302 223 CA) on September 22, 2023. I have not received a response from you.

Once again I must ask that you clarify the status of a matter. This matter has been pursued by people who I believe act under your control.

A "matter" has been before the Ontario Court of Justice. It is referred to as File # 3311 998 22 33100161" and/or "3311998223310016101" and/or "REGINA v. MASSEY, CHRISTINE" and variations thereof. It involves Peterborough Police Service occurrence #: PB22001282.

On January 20, 2022 Ryan Black acting for Peterborough Police Service handcuffed and detained me against my will. He told me I was "charged under the Criminal Code". He gave me papers suggesting that I "must attend court" on "the 16th day of February, 2022" in "Courtroom No. 2" at "70 Simcoe Street, Peterborough, Ontario".

More recently, on September 26, 2023, Paul Murray allegedly representing "REGINA" sent an email (see enclosed) to one of my email addresses. He wrote: "I have brought the information forward to September 26, 2023 in Courtroom #3 at 70 Simcoe. At that time, the Crown will ask the Court to impose a stay of proceedings and as a result the matter will be concluded. You are of course welcome to attend on that date, but if you do not I will confirm with you the matter has been completed."

I have never been served with an application in Form 1. I have never been served with a summons or any proceedings issued by the court, relating to September 26, 2023 or to anything else.

On the record on September 26, 2023 Paul Murray allegedly representing "REGINA" cited Criminal Code section 579 (1), asking Timothy Breen acting as "Judge" to "stay" an alleged "harassment charge" that to my knowledge never existed in the first place. Paul Murray also asked to have the scheduled trial date of December 5, 2023 "vacated" along with an October 18, 2023 date. This was the first that I had heard of anything scheduled for October 18, 2023.

When I tried to explain via "zoom" the background of the alleged "charge", Timothy Breen interrupted and insisted that it had already been "stayed". He had someone mute my audio so that I could not be heard and then someone removed me from the zoom "court".

With regard to "recommencement of proceedings", section 579 (2) mentions a 1 year window and an "expiration of the time within which the proceedings could have been commenced, whichever is the earlier".

Given that 20+ months have already passed since I was handcuffed and allegedly "charged", and that anything more than 18 months from date of "charges" until the end of arguments at a trial is generally considered an unreasonable delay, this suggests that Paul Murray and Timothy Breen effectively ensured that the "matter" would be treated as if no "proceedings" had ever commenced in the first place. However this is not entirely clear.

Also, the justiceservices.jus.gov.on.ca website has been updated since last night to once again list a "Next Court Appearance Date" of "2023-12-05" and a "Next Court Appearance Type" as "TRIAL" for "Case Number" 3311998223310016101 in Peterborough. This is contrary to what was stated on the record in court yesterday. It is damaging to my reputation and causes me stress.

Therefore I ask that you kindly ensure and confirm for me that this "matter" is permanently withdrawn/concluded with no chance of "recommencement", and that no "charge(s)" will show up in any background checks or anything else that could further damage my reputation, and that the entry for "Case Number" 3311998223310016101 will be permanently removed from the the justiceservices.jus.gov.on.ca website.

Note that this matter began with a story told to people acting for Peterborough Police Service by a man who acts as Medical Officer of Health in Peterborough. According to records in "disclosure", this man said that I had spoken to him in a "very threatening voice", "lashed out at" him, hit his right hand, sent him "at least a dozen" emails saying that he had been served with "legal notice", "invaded" his home and his privacy. These statements seem to have been accepted at face value by certain people despite the complete lack of corroborating evidence and the videos that disprove some of them (i.e. <https://rumble.com/vsyncv-peterborough-moh-served-lies-to-police.html>).

In the 20+ months since, I have never been served with any proceedings issued by any court.

Further, no one has given/served me with any claim of trespass or bill of particulars.

In so-called "disclosure" that I accepted from "the Crown" conditionally upon it containing a verified claim from a man or woman that I had trespassed against them causing wrong or harm, I have only been given what appear to be internal corporate forms. One such form is labeled as "Form 2 Information". It is missing elements of the "Form 2" shown in the "Criminal Code". This "Form 2 Information" does not indicate that it was sworn before anyone acting for the Ontario Court of Justice or any other court.

Another form that I obtained from court staff is labeled "Intake Court Endorsement". It bears the name of what appears to be an imaginary court called "Ontario Court of the Justice".

I have had communications with court staff regarding all related files/records. No one acting for the court, or for Peterborough Police Service or allegedly acting for "the Crown" / REGINA has provided me any papers or electronic records bearing the name of the court "Ontario Court of Justice".

People allegedly acting for "the Crown", the court and Peterborough Police Service have given me various papers and/or electronic records bearing the name of what appears to be an imaginary court called "Ontario Court of the Justice". This includes a record labeled "WARRANT FOR ARREST" and another labeled "ENDORSEMENT OF WARRANT".

I have been never been served/provided with any notices or records/files/documents that are addressed to me in relation to this matter. I have only been given what appear to be internal corporate forms. There is nothing for me to respond to.

On March 24, 2022 Stuart Konyer acting as Judge stated on the record that REGINA is "the queen". On the record, he and Sara-Jane MacDonald acting as "the Crown" agreed that I had no dealings with "the queen" or anyone named "REGINA" or on or about January 19th, 2023 and that I don't have a contract with "the queen" or anyone named REGINA and thus I cannot have trespassed against "the queen" or anyone named "REGINA". Further, the woman Elizabeth who was known as "the queen" to many has died and yet this matter of "REGINA v. MASSEY, CHRISTINE" was still being discussed in court today. I therefore conclude that "REGINA" also known as "the queen" is not the woman Elizabeth.

I have never been able to comprehend the position of "REGINA" / "the Crown" and I do not know who or what REGINA is.

I would not be able to prepare for any future court "appearances", should any be scheduled, without being served a coherent claim describing a cause of action involving REGINA.

I have never agreed to a trial or any future "appearances". All 8 of my past "appearances" were coerced special appearances under duress, coercion and threat of "arrest" should I "fail to appear". I have never agreed to perform labour without compensation. I have never given jurisdiction or power of attorney to anyone. I am not incorporated. I have never agreed to contract or joinder in this matter. I notified Paul Murray, other agents, and principal(s) of such

facts on August 3, 2022 and on multiple other occasions and received no response. My previous notifications have included my fee schedule, which is subject to change without notice.

"The Crown" has not given me the list of people who they intend to call as witnesses at a trial should this matter be recommended. If there is any possibility of recommencement despite all of the issues noted above, I require the list.

Given the facts stated above, I ask that you honourably clarify the nature of this matter more generally. Was this "matter" ever filed with Ontario Court of Justice? If so:

- 1) Why are there no records bearing the name of the court?
- 2) Why do some records including the "warrant" have the name of what appears to be an imaginary court?
- 3) Why were Tyler Berry and I never served/provided any claim to respond to?
- 4) Why does the "Form 2 Information" not have a signature indicating that it was sworn before anyone acting as Judge or Justice for the court?
- 5) Why did Stuart Konyer, acting as Judge, schedule a trial for MASSEY, CHRISTINE for December 5, 2023 – a date almost 2 years after the alleged "charges" were allegedly laid - when anything more than 18 months between "charges" and end of arguments at trial is considered an unreasonable delay?
- 6) Was I lawfully obligated to attend court on September 26, 2023 or on any other date? If "yes": on what grounds?

If this matter was never filed with Ontario Court of Justice: how could it have been "stayed"?

I am concerned for my safety. Therefore please respond at the email address listed further below. I ask that you give this matter immediate attention given that 20 months have already passed since I was handcuffed and told that charges were laid.

Not knowing for certain whether this "matter" is permanently withdrawn causes me anxiety and stress.
