Subject: REGINA v. MASSEY, CHRISTINE, R. v MASSEY, CHRISTINE, Case Number
3311998223310016101

This is a follow up to my letter dated August 8, 2023 that was delivered via registered mail (RN 688 754 013 CA) on August 9, 2023, my letter dated August 25, 2023 that was delivered via registered mail (RN 688 754 000 CA) on August 28, 2023, my letter dated September 21, 2023 that was delivered via registered mail (RN 743 302 223 CA) on September 22, 2023 and my letter dated September 27, 2023 that was delivered via registered mail (RN 743 302 206 CA) on September 28, 2023. I have not received a response from you.

Once again I ask that you clarify some issues regarding a matter. This matter has been pursued and documented by people who I believe act under your control.

This matter has been before the Ontario Court of Justice. It is referred to as File # 3311 998 22 33100161 and/or 3311998223310016101 and/or "REGINA v. MASSEY, CHRISTINE" and variations thereof. It involves Peterborough Police Service occurrence #: PB22001282.

This matter was allegedly "stayed" on September 26, 2023 in "courtroom 3" at 70 Simcoe Street in Peterborough while Timothy Breen acted as "judge".

I do not comprehend how this matter could have been "stayed" given the issues that I identified for you in my earlier letters, including the absence of a sworn "information", the absence of a sworn or verified claim from any man or woman that I have trespassed against them causing wrong or harm, the absence of a stated cause of action, the undisclosed nature of "REGINA", the absence of any documentation addressed to me or for me to respond to, the absence of documentation bearing the name "Ontario Court of Justice", the presence of documentation bearing the name of an imaginary court called "Ontario Court of the Justice" and the unreasonable amount of time that has already passed.

I ask you:

How could this matter have been "stayed" in such circumstances?

Will you keep the threat of "recommencement" dangling over my head any longer, or will you assure me in writing that this matter is now permanently withdrawn?

If you choose to keep the threat of "recommencement" dangling over my head, on what grounds?

I also ask you to clarify:

Were the court "proceedings" that I was coerced into "appearing" in public (of the people) or private?

Will my reputation be further damaged on the justiceservices.jus.gov.on.ca website in relation to this matter?

Why do people under your ^{aka Control CM.} control agents encourage people who act as transcriptionists to prepare false/misleading transcripts of "proceedings"?

Is it your position that I was ever lawfully required to attend court? If yes, on what grounds?

When I was last able to check on October 31, 2023 the entry regarding this matter had been removed from the justiceservices.jus.gov.on.ca website. Since then, anyone without a "My Ontario Account" has been blocked from monitoring the site for entries that damage their reputation and from viewing details of court matters. This suggests to me that the courts are private operations since public courts would not have private registries.

I have no desire to open a "My Ontario Account" and cannot lawfully be forced to associate in such a way. Therefore I ask you to assure me in writing that the Peterborough matter has been permanently removed from the website and that no further entry will ever be made.

Norine Nathanson acting as Executive Legal Officer, "SUPERIOR COURT OF JUSTICE" acknowledged in a memo dated March 31, 2021 that CaseLines is owned by Thomson Reuters and that "in locations where CaseLines has been implemented, parties will be asked to register and upload filed court documents to CaseLines".

Norine's memo included a link to a webpage of the "Superior Court of Justice". The webpage reads: "You've received an email from CaseLines advising you to upload documents for your upcoming hearing into CaseLines. What now? Below are tips..."

This further suggests to me that the Ontario courts are private operations.

People who acted as "judge", "justice", "clerk" and "crown attorney" in this matter made false presumptions, acted under the colour of law and disregarded logic, facts, evidence, equity, fairness and the common law rights of man. This further suggests to me that the courts are private operations.

On June 30, 2023 Stuart Konyer acting as "judge" refused to respond when I thrice asked him on the record whether he was acting in commerce while acting as a judge. This further suggests to me that the courts are private operations, and that they operate for-profit.

Court transcripts are not prepared by and obtained from court staff, but by/from "independent authorized court transcriptionists" (and the fees for transcripts are cost-prohibitive for many people). This further suggests to me that the courts are private operations, and that they operate for-profit.

I was forced to contract with an "independent authorized court transcriptionist" in order to obtain a certified "official" transcript of a "proceeding" that took place on June 30, 2022. Said transcript contains inaccuracies involving names and misspellings (and the "information" number is wrong). The "independent authorized court transcriptionist" advised that "This is standard formatting for ALL transcripts, as set out by Court Reporting Services, and I will not be changing them, as that would be contrary to the guidelines I am required to follow."

I was forced again to contract with an "independent authorized court transcriptionist", in order to obtain an "official" transcript of the "proceeding" that took place on September 26, 2023. Said transcript contains inaccuracies involving names and misspellings and the "information" number is wrong. The response of the "independent authorized court transcriptionist" this time was essentially "no comment".

This further suggests to me that the courts are private for-profit operations and that they have nothing to do with law or serving the people.

Court staff have been unhelpful and uncooperative to the point of absurdity since this matter began. They even appear to have participated in mail fraud in January 2022 by falsely claiming that my correctly-addressed registered mail had been sent to the "wrong address", despite having confirmed the address for me in advance in writing, thus preventing me from communicating with the man whose name was electronically "signed" on the "warrant" from an imaginary court that had been used to "arrest" me. They have demonstrated no interest/concern regarding the problematic documentation being pushed through the court in this and other matters.

This further suggests to me that the courts are private for-profit operations and that they have nothing to do with law or serving the people.

Finally, my position is that I was never lawfully obligated to attend court in relation to this matter and that I was coerced under the colour of law. Do you assert otherwise? If "yes": on what grounds?

I am concerned for my safety. Therefore please respond at the email address listed further below. I ask that you give this matter immediate attention given that 22 months have already passed since I was handcuffed and told that charges were laid.

Not knowing for certain whether this "matter" is permanently withdrawn or whether the courts are public or private or whether my reputation will be further damaged causes me anxiety and stress.
