On 22/12/2021 you made the following request for information, which has been dealt with in accordance with the provisions of the Freedom of Information Act 2000.

### Reports and records held by the council regarding the purification of Zika and other Viruses

We have now completed a search for the information which you requested and confirm that this Authority may hold data relevant to your request.

However the Authority is applying the exemption in section 14(1) of the Act.

Although the Authority does not regard the request as patently vexatious, the likelihood of complying would be burdensome and cause a significant burden and impact, resulting in a disproportionate or unjustified level of disruption and we are therefore applying the exemption under section 14 of the Act. Under the terms of the Act, the statutory wording we are required to use for this exemption is: 'Vexatious or repeated requests'.

To clarify the use of the exemption, you have asked for copies of material covering a wide number of health conditions which would not have been produced by the Authority but which it might hold in any of a number of places and could be held by any one of a number of individuals. To identify this material as held would therefore require a wide ranging search by a number of individuals, and as the material would not have originated within the Authority it could therefore be sought by contacting individuals or agencies more likely to have created the material, or by searching published scientific journals. For these reasons the Authority considers this would cause a disproportionate burden in line with ICO guidance.

Having applied an absolute exemption I am not required to consider the balance of public interest for and against disclosure.

Where the request is clearly deliberately vexatious:

(Outline history of request) Against this background the Council considers that on-going requests for information around the decision place a burden on the authority and are designed to cause disruption and annoyance, have the effect of harassing the authority and are obsessive and manifestly unreasonable.

Your communications to a large number of recipients in the authority are hostile in tone and designed to cause disruption and annoyance.

This demonstrates obsessive persistence in relation to a matter already dealt with in the following way (list steps taken to deal with request including involvement of senior officers)

This demonstrates an unwillingness to accept or engage with contrary evidence or views and this is an indicator of someone obsessed with his particular viewpoint, to the exclusion of any other.

# Some further useful wording:

The term "vexatious" is not defined by the Act but following guidance from the Upper Tribunal the ICO considers that a request will be vexatious if it is likely to cause a disproportionate or unjustified level of disruption, irritation or distress. In considering this the context and history in which the request was made can be a major factor in determining whether the request is likely to have such impact.

The tone of language used by the Complainant to describe (X an individual council officer) and the fact that the Complainant has expressed his anger and dissatisfaction with previous Council decisions demonstrates that the request does have the effect of harassing this individual and that the request is obsessive and manifestly unreasonable.

Having applied an absolute exemption I am not required to consider the balance of public interest for and against disclosure.

Where the request is not obviously vexatious but still creates an unreasonable burden, such as an excessive time needed for redaction, which cannot be exempted under s12:

Although the Authority does not necessarily regard your request as vexatious, compliance with your request would cause a disproportionate burden on the Authority and we are therefore applying the exemption under section 14 of the Act. Under the terms of the Act, the statutory wording we are required to use for this exemption is: 'Vexatious or repeated requests'.
