Good evening Arif and Mark,

I am writing to you in your public and private capacities. I believe that Mark is considered the head of 'law enforcement' in the City of Ottawa. Notice to agent is notice to principal, notice to principal is notice to agent.

I obtained publicly available court documents in case number T-294-25 directly from the federal court (see attached email).

In the "applicant's" motion record, in an affidavit on page "020", Exhibit F is described as a "true copy" of an email with attachments, one of which is described as an "Order to Dispose..." On page "058" is page 1 of one of the attachments, a document labelled "...Notice Requirement to Dispose..."

In the "respondent's" motion record, in the affidavit on page "006", Exhibit C is claimed to be a "true copy" of the (same) "Order" (to dispose...). On page "034" is the first page of the document ("Exhibit C") labelled "...Notice Requirement to Dispose..." The entire header and footer are missing from the first page of this document, as compared to the "true copy" filed by the "applicant".

So one of these documents is a forgery and it seems very clear, in my personal opinion, that the forged version is the one supplied by the responding side, specifically by the woman identified as Cathy Furness who acts as "Deputy Chief Veterinary Officer for Canada".

Forgery is a criminal offence. I assume that filing a false statement and forged evidence into court is as well.

The motion records in question are attached. I have already pointed out this issue to court staff yesterday via email to FC_Reception_CF@cas-satj.gc.ca and to someone on the "applicant's" side and have blind copied several people to witness this email.

Would you kindly acknowledge receipt?

If I do not hear back from you by Monday January 17, 2025 at 6pm EST, I will consider this your tacit agreement that the woman Cathy Furness and the "respondent's" lawyers filed a forged document into federal court.

(Cathy Furness also falsely claims in her affidavit to have "personal knowledge" of imaginary viruses that are claimed to be submicroscopic and hence invisible to the naked eye and even to a light microscope and for which no valid scientific evidence exists - as shown in the virology literature which is embarrassingly illogical and pseudoscientific by definition and which aligns with the hundreds of official confessions that I personally have collected from 225 institutions in 40 countries. This includes responses from CFIA, PHAC, HC, CDC, FDA, USDA, etc. specifically on "avian influenza virus". Mark Holland's tacit agreement that "avian influenza virus" is another deadly hoax is already established - see attached. I will send you my notarized affidavit on that topic in a separate email.)
