4. - that **scientifically demonstrate contagion of the illness / symptoms** that are allegedly caused by purported "avian influenza viruses", or
5. - wherein **any test that purportedly relates to the alleged "avian influenza virus" was validated** (logically, this would require the alleged virus to first be proven to exist).

Hello Margarita,

Perhaps someone has misled you because in my order, attached, I actually wrote (emphasis added):

*"Timeframe: **If a timeframe is necessary, please use January 1, 1955 - the date of the search.**"*

It is unclear to me what anyone could possibly find unclear about that.

Regarding this statement in your email:

*"Furthermore, please note that AAFC's Access to Information and Privacy (ATIP) Office **will now be using epost ConnectTM** to deliver the electronic release package to you. To receive your ATIP release package, **you will need to sign up for an account with epost ConnectTM...**"*

I am not aware of any provision in the legislation that allows an institution to dictate that I receive a release package via epost ConnectTM or that I sign up for an account with any 3rd party or that I read or agree to the Terms of Use and/or the Privacy Statement of any 3rd party.

Furthermore, the attachment you provided states:

*"**If you ... do not wish to participate** in this service, please contact us at aafc.atip-aiprp.aac@canada.ca."*

Therefore it is unclear to me why you would make such a claim, especially given that in my order I already made it clear how the response is to be conveyed and that I do not agree to such an arrangement:

*"Searchable pdf documents **sent to me via email**; please don't ship anything to me....**Privacy: I do not agree to this order or "personal information" being shared with any 3rd parties** including those that provide FOIA services, without my explicit written consent."*


I will not be signing up for the unwanted account.
