Last year, Andrii Komar filed a freedom of information request with Finland's National Institute for Health and Welfare ("THL") ([pgs 2-4](#)). He sought all studies held by the institution, from anywhere in the world, that describe someone finding and purifying particles thought to be H5N1, H7N9 or any other new or rare subtype of the alleged influenza A virus, from a patient sample (bodily fluid or tissue).

Below is gmail's auto-translation of the request to English ([pg 6](#)):

Detailed description of the requested documents:

All studies and/or reports from anywhere in the world describing (e.g. filtration, ultracentrifugation and chromatography) the purification of disease caused by influenza A virus subtypes H5N1 or H7N9 or other new or rare subtypes and all its strains from a sample taken directly from a patient, where the patient sample has not been previously combined with any other source of genetic material (such as monkey kidney cells or Vero cells; fetal bovine serum, chicken embryo, etc.).

Please note that I am not asking for studies/reports where researchers failed to clean up the virus, but instead:

- cultivated/grown something, and/or
- performed an amplification test (e.g. PCR), and/or
- created a genome from millions of sequences found in the unpurified material, and/or
- took electron microscope images of uncleaned objects.

I already know that according to virus theory, viral replication requires cells. Therefore, I am not requesting documents that describe viral replication without cells. I am also not requesting documents that describe the virus floating in a vacuum or patient private information.

I am only requesting documents that describe the purification of the virus (separating the virus from everything else in the patient sample, in accordance with laboratory practice in purifying other very small particles).

Purification, as many now realize, would be a necessary foundational step in attempting to show that a virus with the claimed "genome" and proteins actually exists and causes illness in "hosts". Purification is required in order for valid sequencing and characterization to take place (for identification purposes), and it is essential in order to conduct a valid, rigorous controlled experiment to test a falsifiable hypothesis regarding causation of illness.

Without this step there cannot be any scientific evidence of a virus.

You sent a message to the National Institute for Health and Welfare on 11 July 2024 and requested, in accordance with the Act on the Openness of Government Activities (621/1999, hereinafter referred to as the Openness Act), "publications or scientific studies that describe the process of direct purification of a disease caused by the H5N1 or H7N9 subtype of the influenza A virus or another new or rare subtype from a patient sample". We apologize that you have had to wait for a response. Due to the research and expert duties of the Institute, the National Institute for Health and Welfare has extensive access to scientific literature, including a library and various collections of scientific articles, for internal use, such as information retrieval. However, such documents are not, in accordance with Section 5, Subsection 3, Paragraph 3 of the Openness Act, in the nature of official documents that would be provided in response to requests for information under the Openness Act (the so-called library clause). When responding to requests under the Freedom of Information Act, for example, new literature reviews or other similar documents will not be produced. If you wish, you have the right to receive an appealable administrative decision that the documents you requested will not be provided to you. If you wish to submit the matter to the authorities for resolution, you can notify them by replying to this message.

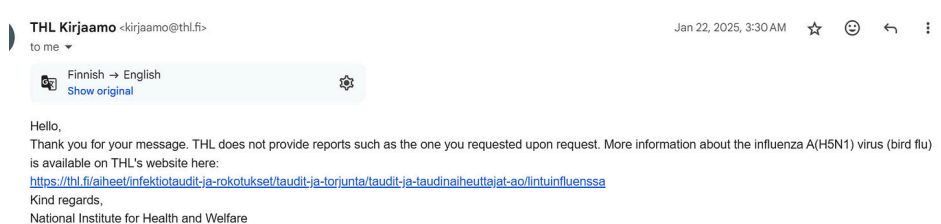
Hi Tuuli,

Predictably, even though Tuuli responded ([pgs 1 and 9](#)), she did not provide or cite any scientific evidence and there was none to be found at the [webpage](#) to which she directed me.



If you are wondering how I know that Tuuli Karppinen is a lawyer, she identified as such in 2022 when responding to a [similar request](#) regarding the imaginary SARS-COV-2, as shown in the screenshot further below.

And, similar to the stunning March 1, 2021 admission ([pg 3](#)) made by the "subject matter experts" ("SME") at the CDC and conveyed in an official Freedom Of Information Act response, and the stunning summer of 2020 admission made by "experts" at Mount Sinai Hospital in Toronto - not just **one** time but a **2nd time** as well - in their official FOI response, Tuuli Karppinen at Finland's Department of Health and Welfare stated in her 2022 email shown below that finding and "isolating" any virus (in the every day sense of the word, aka purifying it) from its alleged locations ("hosts") is "*not at all possible*" and isn't done in the so-called "*science*" of virology.

Hey,

We have examined your request for information on 16.3.2022.

The right of access to information pursuant to Chapter 3 of the Act on Public Access to the Activities of Public Authorities (621/1999, hereinafter "the Public Access to Information Act") applies to information entered in the documents of public authorities. According to section 5 (3) (3) of the Public Access to Information Act, documents obtained for the authority's internal training, information retrieval or other comparable internal use are not considered to be documents of the authority. For example, scientific literature and libraries collected by the authority for its own activities are therefore not documents of the authority that would be provided in response to requests for information under the Public Access to Information Act. As the right of access under Chapter 3 of the Public Access to Information Act is only information contained in existing documents, new documents (such as bibliographies) are in principle produced in response to requests.

THL has examined whether it is in possession of authority documents, the subject of your request for a reply. No such documents have been found. Given that the term 'isolate' has been used in a different sense in the request for information than is well established in science and that 'isolating' any virus within the meaning of the request for information is not at all possible, it is likely that the entire file does not exist at all.

If you wish, you have the right to have the matter confirmed by an authority. If you would like the matter to be referred to an authority for confirmation, you can report it by replying to this message.
